



## Group to Tour New Paterno Library

On Friday April 27 CPHSLA members will hold their Spring Meeting in Happy Valley. The business meeting will begin at 10am followed at 11 by a "Let's Share" discussion session, in which members will share information they have gathered from various meetings and conferences. After a catered lunch, the group will tour the new Paterno Library.

The Paterno Library broke ground in April 1997 and was dedicated on September 8, 2000. With 130,000 square feet of new space and 360,000 square feet of renovated space, this library along with the Pattee Library contains 500,000 square feet! Joe & Sue Paterno were leaders in the Campaign for the Library, which raised \$13.75 million in private gifts to help fund the \$34.4 million project.

In the Paterno Library are the Eberly Family Special Collections Library, including rare books and manuscripts, as well as the Penn State University Archives; the Maps Library, which contains the largest cartographic collection in Pennsylvania; the Social Sciences Library; the Business Library; the Life Sciences Library; and the Education and Behavioral Sciences Library.

During the construction of the Paterno Library, Pattee Library underwent significant renovations and the east wing became part of the new library.
