## New Business:

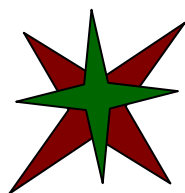

Sue distributed an interest form for librarians to apply for consideration to participate in a value study funded by NN/LM MAR. This study will focus on physician use of health information for clinical care, and the support of hospital librarians in providing this information. She pointed out the responsibilities of librarian participants on page 2 of the form.
